PROPERTY DESCRIPTION

Ivana Court is situated within Ajah environs just off the Lekki/Epe Expressway, in the neighborhood of other choice estates and landmarks such as Thomas Estate, Royal Gardens, and Orchid Gardens, Lekki conservation, Ajah Multipurpose Market, Beach Resorts, Dominos Pizza, Coldstone Creamery, Atm Galleries, Shopping malls GIG Logistics, Furniture Square.

PAYMENT
